# 1. What is this product?

#### English law governed notes

The product is designed to provide a return in the form of a cash payment on the maturity date. The amount of this payment will depend on the change in value of the preference shares, which in turn will depend on the performance of the underlying. The product has a fixed term and will terminate on the maturity date. The payment at maturity will not exceed GBP 1.6875. If, at maturity, the underlying has fallen below 60.00% of the initial reference level, the product may return less than the product notional amount or described in more detail in even zero.

On termination of the product on the maturity date you will receive:

- if the final reference level is at or above 85.00% of the initial reference level, a cash payment equal to (i) GBP 1.00 plus (ii) an 1. amount directly linked to the performance of the underlying. This amount will equal (i) GBP 2.75 (i.e., 275.00% of the product notional amount) multiplied by (ii) (x) (A) the final reference level divided by (B) the initial reference level minus (y) 85.00%. However, if this cash payment exceeds GBP 1.6875, you will only receive GBP 1.6875 (the maximum payment);
- 2. if the final reference level is at or above 60.00% of the initial reference level and below 85.00% of the initial reference level, a cash payment equal to GBP 1.00; or
- 3 if the final reference level is below 60.00% of the initial reference level, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) the product notional amount multiplied by (ii) (A) the final reference level divided by (B) the initial reference level.

Investors should note that the payments described above are based on the expected value of the preference shares. Therefore any return you may receive on the product depends directly on the value of the preference shares. As such, your return is only indirectly dependent on the underlying.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product, as applicable, early. These events are specified in the product terms and principally relate to the product and the product issuer. The preference shares in turn contain provisions allowing the preference shares to be adjusted or terminated early in the case of certain exceptional events, in particular relating to the underlying. Any such adjustments or early termination are likely to affect the amount and timing of return you receive under the product, meaning the return (if any) that you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

### 2. What are the risks and what could I get in return?





#### Lower risk



The risk indicator assumes you keep the product for 6 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

### 3. What happens if Morgan Stanley & Co. International plc is unable to pay out?

#### 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest GBP 10,000. The figures are estimates and may change in the future.

## 5. How long should I hold it and can I take money out early?

#### **Recommended holding period: 6 years**

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 15 May 2025 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is listed) or (2) offexchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable.
