### Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by the Packaged Retail and Insurance-Based Investment Products Regulation ("PRIIPs") to help you understand the key features, risks, costs and potential gains and losses of this product and to help you compare it with other products covered by PRIIPs.

### 1. What is this product?

<b>Objectives</b> (Terms that appear in bold in this section are described in more detail in the table(s) below.)	<p>The product is designed to provide a return in the form of (1) conditional interest payments and (2) a cash payment on termination of the product. The timing and amount of these payments will depend on the performance of the <b>underlyings</b>. The product has a fixed term and will terminate on the <b>maturity date</b>, unless terminated early. If, at maturity, the <b>worst performing underlying</b> has fallen below its <b>barrier level</b>, the product may return less than the <b>product notional amount</b> or even zero.</p> <p><b>Early termination following an autocall:</b> The product will terminate prior to the <b>maturity date</b> if, on any <b>autocall observation date</b>, the <b>reference level</b> of the <b>worst performing underlying</b> is at or above its <b>autocall barrier level</b>. 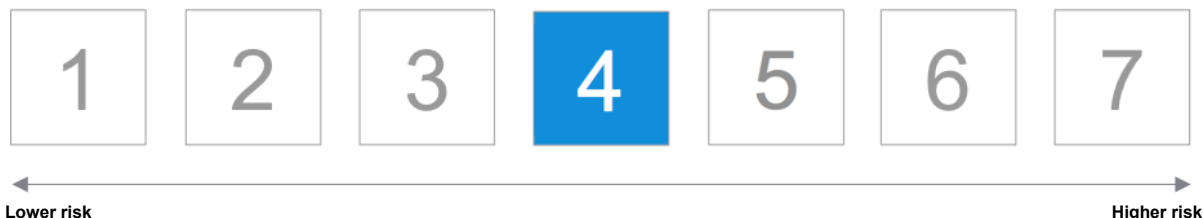

## 2. What are the risks and what could I get in return?

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact our capacity to pay you.

This table shows the money you could get back over the next 10 years as well as the annualized return calculated on a compounded basis under different scenarios, assuming that you invest GBP 10,000.

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. ## 3. What happens if Morgan Stanley & Co. International plc is unable to pay out?

## 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest GBP 10,000. The figures are estimates and may change in the future.

## 5. How long should I hold it and can I take money out early?

### Recommended holding period: 10 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 29 November 2029 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (if the product is exchange traded) or (2) off-exchange, where an offer for such product exists. No fees or penalties will be charged by the issuer for any such transaction, however an execution fee might be chargeable by your broker if applicable. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
