Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type The product is in the form of a note issued under Cayman law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by Goldman Sachs International.

Objectives The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the class 1317 preference shares issued by GOLDMAN SACHS (CAYMAN) LIMITED (ISIN: GS00PSH13176) (the preference shares). The performance of the preference shares is in turn linked to the performance of the FTSE 100 Index (the underlying asset). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than September 25, 2028. However, the product may terminate early depending on the performance of the underlying asset. Each note has a face value of GBP 1. The issue price is 100.00% of the face value. The product will be listed on Luxembourg Stock Exchange (Main Segment). Autocall feature: If the closing price of the underlying asset on any autocall observation date is at or above 100.00% of the initial reference price, the product will terminate on the corresponding autocall payment date. In this case, you will receive the autocall payment for each note that you hold. Autocall observation dates are each trading day from and including September 18, 2023 to but excluding September 18, 2028. Autocall payment dates are the 5th business day following each autocall observation date. Autocall payment is calculated as GBP 1 multiplied by the sum of (a) 100% and (b) the sum of (i) 6.50% multiplied by (732/365) and (ii) 6.50% multiplied with the accrual fraction for the calculation period. The accrual fraction applicable to the calculation period will be (N/365), where (N) is the number of calendar days in the calculation period. The calculation period runs from and including September 18, 2023 to and excluding the date on which an autocall has occurred. For the avoidance of doubt, N shall be equal to zero in respect of an autocall occurring on September 18, 2023.

Repayment at maturity:

This section applies only if no autocall occurs as described above. On September 25, 2028, for each note that you hold:

If the closing price of the underlying asset on September 18, 2028 is at least equal to the trigger price, you will receive GBP

- 1.00 multiplied by the sum of (i) 100% plus (ii) 6.50% multiplied with 2559/365; or
- 2. If the closing price of the underlying asset on September 18, 2028 is at least equal to the barrier price but lower than the trigger price, you will receive GBP 1.00;
- 3. <u>Otherwise</u>, you will receive GBP 1.00 multiplied by (i) the closing price of the underlying asset on September 18, 2028 divided by (ii) the strike price of the underlying asset.

The initial reference price of the underlying asset is the closing price on September 16, 2021.

The strike price is 100.00% of the initial reference price. The barrier price is 65.00% of the initial reference price. The trigger price is 100.00% of the initial reference price.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

- The product is intended to be offered to retail investors who:

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 7 years. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This takes into account two elements: (1) the market risk

- that the potential losses for future performance are rated at a medium level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The recommended holding period for the product is 7 years as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity. The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-bycase basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product back to the manufacturer.
