

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

**Type** The product is in the form of a note issued under Cayman law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by Goldman Sachs International.

**Objectives** The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the class 1464 preference shares issued by GOLDMAN SACHS (CAYMAN) LIMITED (ISIN: GS00PSH14646) (the preference shares). The performance of the preference shares is in turn linked to the performance of the FTSE 100 Index (the **underlying asset**). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than December 27, 2028. However, the product may terminate early depending on the performance of the underlying asset. Each note has a face value of GBP 1. The issue price is 100.00% of the face value. The product will be listed on Luxembourg Stock Exchange (Euro MTF).  
**Autocall feature:** If the closing price of the underlying asset on any autocall observation date is at or above 100.00% of the initial reference price, the product will terminate on the corresponding autocall payment date. In this case, you will receive the autocall payment for each note that you hold. Autocall observation dates are each trading day from and including December 18, 2023 to but excluding December 18, 2028. Autocall payment dates are the 5<sup>th</sup> business day following each autocall observation date. Autocall payment is calculated as GBP 1 multiplied by the sum of (a) 100% and (b) the sum of (i) 6.25% multiplied by (731/365) and (ii) 6.25% multiplied with the accrual fraction for the calculation period. The accrual fraction applicable to the calculation period will be (N/365), where (N) is the number of calendar days in the calculation period. The calculation period runs from and including December 18, 2023 to and excluding the date on which an autocall has occurred. For the avoidance of doubt, N shall be equal to zero in respect of an autocall occurring on December 18, 2023.

### Repayment at maturity:

This section applies only if no autocall occurs as described above.

On December 27, 2028, for each note that you hold:

- If the closing price of the underlying asset on December 18, 2028 is at least equal to the trigger price, you will receive GBP 1.00 multiplied by the sum of (i) 100% plus (ii) 6.25% multiplied with 2558/365; or
- If the closing price of the underlying asset on December 18, 2028 is at least equal to the barrier price but lower than the trigger price, you will receive GBP 1.00;
- Otherwise, you will receive GBP 1.00 multiplied by (i) the closing price of the underlying asset on December 18, 2028 divided by (ii) the strike price of the underlying asset.

The initial reference price of the underlying asset is the closing price on December 17, 2021.

The strike price is 100.00% of the initial reference price. The barrier price is 65.00% of the initial reference price. The trigger price is 100.00% of the initial reference price.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

## Intended retail investor

The product is intended to be offered to retail investors who:

- have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
- seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
- accept the risk that the issuer or guarantor could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment;
- are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below; and
- are making use of professional advice.

## What are the risks and what could I get in return?

### Risk indicator

The risk indicator assumes you keep the product for 7 years. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

Higher risk

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest GBP 10,000.00. The figures are estimates and may change in the future.

The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. Disregarding the impact on your return in that scenario, the estimated entry and exit costs as a percentage of the face value are estimated to be 6.32% if you cash in after year 1, 8.91% if you cash in after 4 years and 4.16% if you cash in after the recommended holding period.

The costs shown in the table above represent the split of the reduction in yield shown in the costs over time table at the end of the recommended holding period. The split of the actual estimated costs of the product is estimated to be as follows: entry costs: 4.16% and exit costs: 0.00%.

### How long should I hold it and can I take money out early?

#### **Recommended holding period: 7 years**

The recommended holding period for the product is 7 years as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product back to the manufacturer.
